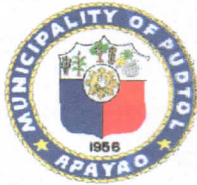
“A RESOLUTION REQUESTING FUNDS FROM THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) DISTRICT II FOR THE CONSTRUCTION OF RETAINING WALL LOCATED AT BARANGAY POBLACION, PUDTOL, APAYAO”.

WHEREAS, Section 17, subsection *b*, of the Local Government Code of 1991 states that item (2) par. (viii) , Infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of municipal funds including, but not limited to, municipal roads and bridges; school building and other facilities for elementary and secondary schools; clinics, health centers and other health facilities necessary to carry out health services; communal irrigation, small water impounding projects and other similar projects; fish ports; artesian wells, spring development, rainwater collectors and water supply systems; seawalls, dikes, drainage and sewerage, and flood control; traffic signals and road signs; and similar facilities.

WHEREAS, the DPWH is one of the 3 departments of the government undertaking major infrastructure projects. DPWH is mandated to undertake (a) the planning of infrastructure, such as national roads and bridges, flood control, water resources projects and (b) the design and construction and maintenance of national roads and bridges and major flood control systems and other public works in accordance with national development objectives;

WHEREAS, infrastructure refers to all the physical structures used by society and industry for enhancing its productivity or for the production of goods and services which include

WHEREAS, the Municipal Government of Pudtol is also one with the several programs of the National Government in alleviating the poverty rate in the country by identifying possible projects that does not only aim for infrastructure development but also to create employment among the people.

WHEREAS, a retaining wall is very necessary to put up along the highway, in front of the Municipal Health Unit of Pudtol, of which said area serves as the terminal of Public Utility Vans and also a government facility where workers are always in the building every day.

WHEREAS, the retaining wall aims to prevent soil erosion and secure the safety of the government facility and to add the terminal space for the PUVs to avoid traffic congestions especially during market days.


WHEREFORE, on motion of Hon. Elmer P. Canonizado, SB Committee Chair on Infrastructure, with the accord of all the members present, be it;


RESOLVED FINALLY, to send copy of this resolution to DPWH-APAYAO District II for their favorable consideration and prompt action.


