“A RESOLUTION REQUESTING THE NATIONAL COMMISSION ON CULTURE AND THE ARTS (NCCA) FOR THE RESTORATION OF THE CHURCH RUINS LOCATED AT MATAGUISI AND EMILIA, PUDTOL, APAYAO”

WHEREAS, Sections 14, 15, and 16, Article XIV of the 1987 Constitution states that (14) the State shall foster the preservation, enrichment and dynamic evolution of a Filipino culture based on the principle of unity in diversity in a climate of free artistic and intellectual expression. The Constitution likewise states that (15) the State shall conserve, develop, promote and popularize the nation’s historical and cultural heritage and resources, as well as artistic creations. And (16) it further provides that all the country’s artistic and historic wealth constitutes the cultural treasure of the nation and shall be under the protection of the State, which may regulate its disposition;

WHEREAS, RA 7356 otherwise known as the National Commission for Culture and the Arts (NCCA) Title III, Section 7 which states that it is the duty of every citizen to preserve and conserve the Filipino historical and cultural heritage and resources. The retrieval and conservation of artifacts of Filipino culture and history shall be vigorously pursued;

WHEREAS, preservation and restoration of historical structures play a cultural role since these reminds the people of the history happened in the olden times and it is a way of showing respect to our ancestors;


RESOLVED FINALLY, to send copies of this resolution to the NCCA and all authorities concerned for their information and action.
